Dear Friends and Neighbors:

Our 2021-2022 season was certainly one for the history books. Through the generosity of 294 families and 8 businesses The Mirasol Foundation was able to give \$424,000.00 in grants to 36 Palm Beach County Charities. During the early summer an additional \$27,000.00 was given out in emergency funding to two of our charities that deal with food insufficiency in our County. So, from all of us on the Foundation Board, and the Gifts and Grants Committee, thank you for your generosity. For those of you that may not be aware, there are at least 181,000 people in Palm Beach County that suffer from food insufficiency.

As you will see as you browse through this report and see the categories of causes that we give to, you will hopefully become more aware of the needs within Palm Beach County. Please take

a moment to look at the names of each of these charities, or go onto our website and watch our new video, as it will hopefully speak to you about the tremendous need out there.

On March 11th, close to 300 of you came to Keep Calm and Party On. We had an absolutely wonderful night of great food, dancing, and auctions. Not only did we double our past level of attendance, we also raised a record amount of money.

This season we will continue with our seed parties. They are member-sponsored, non-soliciting, Happy Hours, where we bring in a charity to give a very brief talk, along with a person who has directly benefited from our funding. It's a great way to gather with friends for food and drinks, and gain a better understanding about how we help Palm Beach County Charities.

Please mark your calendars for upcoming events this season: On January 26, 2023, we will be holding our first Tennis Event. It will feature clinics and demonstrations by some very famous professional players, along with great food and drink, and lots of other fun things to do.

On March 11, 2023, we will be holding another Gala featuring our favorite Studio 54 Band, great auction items, and of course a wonderful menu prepared by our staff. So, get your dancing shoes ready.

Lastly, I want to remind everyone that Mirasol is a community of 1170 families. If you noticed in my introduction, just 294 of those contributed generously to help. I ask you to just imagine if more of you became interested in helping, what miracles we could perform.



**DANIEL LEHRHOFF** President





MARILYN WILSON Vice President

The Vice President is responsible for presiding at board meetings in the absence of, or at the request of the President. In addition to the VP duties of regulatory compliance and by-laws maintenance, Marilyn has taken on additional responsibilities. She develops Foundation communications to the community with the assistance of the Mirasol Communications director. Last year, she updated the donor software and continues to learn new functions to support our fundraising events. She has re-vamped the Foundation website with more information, photos, software and video links. This is her first year as Vice President.



**ED BONDER** Treasurer

The Treasurer is responsible for overseeing all financial operations of the Foundation. He prepares and creates many statistical reports that allow MFI to analyze, evaluate and plan for the future. He develops an annual operating budget, as well as budgets for all fundraising events. Part of his responsibility is to make sure that the Foundation's internal financial records are prepared in a manner sufficient for our independent accountants, to prepare our annual audited financial statements, as well as the preparation of our income tax returns. He maintains a relationship with the bank, insurance provider, its independent accountants and its investment brokerage firm. He is responsible for filing annual reports with Florida State agencies, overseeing our insurance needs and executing transactions relating to the sale of donated securities.



JILL GUZ Secretary

The Secretary is responsible for maintaining communications as needed between board members and charities, as well as residents and board members. She is responsible for recording and distributing the minutes of all MFI meetings. Because of her prior experiences on the Gifts and Grants Committee, Jill is also responsible for accepting grant applications from the charities and forwarding them to the chairpersons of the Gifts and Grants Committee. She is responsible for reviewing all email received. Basically, she is the center of the hub disseminating information from the source to the appropriate individuals.



**JACK WILEN** 

Jack is the Liaison Officer between the MFI Board and the Gifts and Grants Committee. While Jack is new to that position, he has previously served on the Gifts and Grants Committee as a member. He will cochair our efforts to coordinate small gatherings ("seed parties") throughout the year to help educate our membership on how The Foundation works and where the donations go.

#### **MICHAEL'S STORY**



Michael\* is an energetic, athletic, smart 10-year-old boy. He loves basketball, eating sweets, and playing video games with his friends. When asked what he'd call the book written about his life, he said without hesitation... "Mighty Michael!"

What you wouldn't know is that in 2008 when Michael was a toddler, he was removed from his biological mother due to allegations of neglect and sexual abuse. In his short life, Michael has been bounced around to 13 foster homes. After behavioral issues at his last foster home caused him to be stepped up into a locked facility, Michael thought his foster family had abandoned him, and that they were just another "family" he could check off of his list. He was then referred to live at HomeSafe's Sylvester Family campus in West Palm to receive our intensive therapeutic support services.

When Michael arrived at HomeSafe, he was angry and ready to fight. He had a hard time expressing his trauma because it brought back too many horrible memories. Michael said he always walked with his head down and just prayed things would get better. He admits he was mad, but says he never allowed himself to be scared. Michael immediately made three friends at HomeSafe and connected with the staff. He said his program supervisor, Mr. Derek, and his therapists, Ms. Stephanie and Ms. Brittney, were always there for him. Every day after school, Michael and Ms. Stephanie would jog around the campus and talk through his feelings. Ms. Brittney bonded with Michael over basketball, creating games to incorporate into his therapy.

After a year at HomeSafe, Michael has completed his treatment plan and has learned to manage his anger. He's grown into a more empathetic and self-aware person. Michael is grateful for the relationships he's formed at HomeSafe, and most importantly he is excited to return to his foster family who has welcomed him back into their home.

There are hundreds of stories like Michael's. Stories of children who have been able to heal from their trauma and find confidence in their future. HomeSafe is grateful for the Mirasol Foundation's help transforming lives and giving these children a brighter path forward.

## **COMMUNITY SERVICES**



At the end of the Foundation's fiscal year, the total amount of grant money given to 36 501(c)(3) organizations was \$424,000.






